

For me, this is the only guide to use. Minister taxes are poorly understood even by many of the well known tax preparation firms. I think that Pastors spend a fortune on taxes because they turn them over to "tax preparation experts" who don't get it. If you are a Minister, unless you inherited some complicated investments or offshore accounts, you CAN do your own taxes with this guide. I have used Zondervan's annual Minister's Tax and Financial Guides for probably 12 years. Each year, this guide contains what is called "The 1040 Challenge" and leads you through your form 1040 line by line telling you what to do with each line. The guides are updated each year with the latest IRS laws and codes, especially those affecting Ministers. If you want to save a fortune in tax preparation fees and want your taxes handled by the only person who truly cares about them, then hire yourself and this book. It's really not all that hard. Even better, this book is a tax write off!

I buy a copy of this book every year for use with my personal taxes. Churches don't tend to get audited very often but, because of the strange appearance of minister's returns, they are audited more often. By following the steps in this book, I have always gotten my taxes done earlier than most of the other preachers I know, I don't have to pay a professional to prepare my taxes, and I am prepared with references and the knowledge I have done what is right in the case of an audit. I have only been audited one time and after filling out their questionnaire, I was told everything was good to go - mostly thanks to the information in this book. If you're a minister and you do your own taxes, not only will this book help you complete your return correctly, but it also has good advice to help you better manage your finances in the coming year. While I appreciate tax professionals, minister's taxes are so different from everyone else's that most CPAs or other professionals I have talked with are unfamiliar with how to complete them properly. You \_will\_ wind up paying far too much in taxes if you take your information to someone unfamiliar with how to prepare them properly. Just get a copy of this book, read it all the way through once, and then complete your taxes using the book as a guide. Also, make sure to read the instructions on all the tax forms very carefully.
