

This practical approach helps law students with common problems and dilemmas: substitutions for "legalese" lists of commonly used legal idioms, spelling tips, advice on organization and the legal writing process, proofreading, and document design. Modeled after handbooks used at the undergraduate level, the Handbook features a small trim size, comb-binding, clear organization, two-color printing, and helpful design elements to highlight important information.
