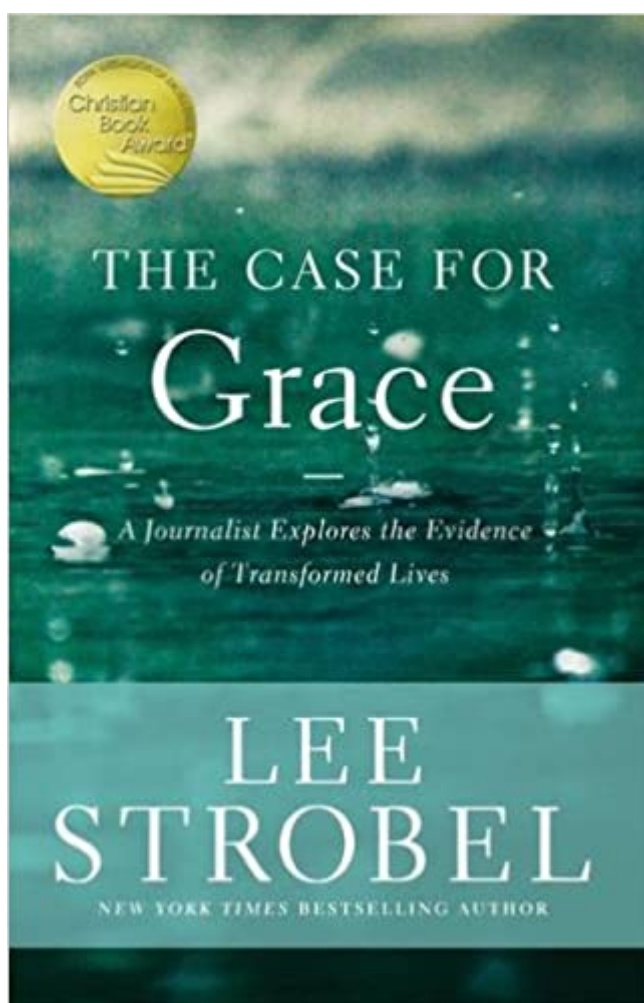

I've read all of his books and love them. This is a great book. The reason I didn't give it 5 stars was 20% of the book was a study guide with questions. This book came in the mail yesterday after work. I spent the evening sneaking in as much of it as I possibly could. Absolutely wonderful! His other books have presented Christianity as the most reasonable and rational conclusion based on the evidence, but this book is different. Unlike the others, though, it doesn't focus its address to the mind, but to the heart. No one want to believe anything that isn't true, to be sure, but the extravagant, mind-blowing, awesome grace of God--that is what we long for in the deepest recesses of our hearts. It is this grace that can touch, heal and transform the severest brokenness in our lives. Only authentic Christianity offers this kind of grace. I don't say that in arrogance or to slight any other religion or people. It's just reality. As someone once said, I should not be upset to find out that there was not multiple cures for a disease I had--I would be thrilled that there was one. Be prepared to weep tears of joy as you read, and, if you're like me, be prepared to immediately buy other copies to give out to others.

story. If for that chapter alone, the book is worth ten times the price, and all the chapters are impressive. For an update on *The Girl Nobody Loved*, Stephanie Fast has written a biographical novel of her life in her book *"She is Mine."* I will likely buy more of both books. My family and friends need this wonderful message of love and grace.

Each chapter is about a different character in his or her journey to faith in Jesus. It's very well written and is holding my attention. I just read the chapter about a Korean half-breed orphan girl, who was abandoned by her mother and suffered incredible abuse. Somehow, she survived living on her own as a toddler, stealing from farmers, sleeping in foxholes and other makeshift places. When she was adopted, it was awhile before she realized that she was her new parents' daughter and not their slave.

I am a big Lee Strobel fan, but this book definitely caught me by surprise. It follows a similar journalistic interview style, but contains a lot more heartfelt, personal stories than ever before. It definitely pushed me to better understand God's grace. I absolutely love it!
